Recording COVID-19 deaths of people with learning disabilities

The LeDeR Programme has adjusted its notification process to ensure any people with learning disabilities who die from a coronavirus-related cause are recorded appropriately. Anyone reporting a death to the University of Bristol's LeDeR team will be asked whether it is likely that the death was related to COVID-19. A supplementary question has also been added to the LeDeR Review System so reviewers and Local Area Contacts (LACs) can formally record deaths as being caused by COVID-19. Any reviewers or LACs who have questions about these changes should contact their Regional Coordinator. The University will be providing weekly updates to NHS England on the total number of COVID-19 deaths reported to the LeDeR programme.

Reviews of deaths related to COVID-19

It would be helpful if reviewers could include certain information when reviewing any deaths related to COVID19. This includes: how the early symptoms of illness were identified and responded to; the treatment received, including admission to hospital and ITU; the decision-making processes that guided a person's treatment plan; DNACPR decisions made

and their rationale; and any reasonable adjustments required and made. It would also be helpful for reviewers to include information specific to risk factors for COVID 19 in the general population: if the person was obese; what, if any, underlying health conditions they had; if they were a smoker; if they had had previous episodes of respiratory disease; if they were being 'shielded'; and if they relied on others to help them to wash their hands and maintain social distance.
